Subject: Resolution No. 2017-013: Amending the 2017 Fee Schedule to Increase the Menahga Memorial Park and Campground Fees

Summary statement: Resolution No. 2017-013 amends the Fee Schedule by amending the Memorial Park and Campground fees.

As was discussed during the June 1, 2017, special meeting, each campsite and pavilion was increased by \$5. The weekly rates were also increased by \$5 and calculated for one free night, as opposed to two.

The effective date for the increase is June 15, 2017. The increase will not be retroactive for those who have already paid for their pavilion rental or who have arrived at the Campground and paid for their campsite prior to June 15.

A Resolution of the Menahga City Council Amending the 2017 Fee Schedule to Increase the Menahga Memorial Park and Campground Fees

WHEREAS, the City Council adopted Resolution No. 2017-005 setting the 2017 City of Menahga fees; and

WHEREAS, the City Council wishes to amend the schedule as follows (new language is underlined and deleted language is stricken):

Dump fee	\$ <u>10.00</u>	5.00
Pavilion rental – per day	\$ <u>35.00</u>	30.00
Nightly campsite rental:		
Primitive	\$ <u>20.00</u>	15.00
Campsite with electric	\$ <u>25.00</u>	20.00
Campsite with electric and water	\$ <u>30.00</u>	25.00
Weekly campsite rental:		
Primitive	\$ <u>120.00</u>	75.00
Campsite with electric	\$ <u>150.00</u>	100.00
Campsite with electric and water	\$ <u>180.00</u>	125.00

NOW, THEREFORE BE IT RESOLVED that the City of Menahga increase the Menahga Memorial Park and Campground fees, effective June 15, 2017, and that the rate increase is not retroactive.
