A Resolution of the Menahga City Council Authorizing Participation in the Community Concern for Youth Program with Todd-Wadena Community Corrections

WHEREAS, the Community Concern for Youth program is a short-term intervention and diversion program operated by Todd-Wadena County Community Corrections; and

WHEREAS, the program works with youth and their families to help resolve conflicts at home, school or in their personal lives; and

WHEREAS, it is also a program for first-time offenders that holds them accountable for their actions to prevent court involvement; and

WHEREAS, services include one-on-one counseling and referrals to other agencies for young people experiencing personal, family, chemical or school related problems.

NOW, THEREFORE BE IT RESOLVED by the Menahga City Council that Todd County act as sponsoring unit of government for the project entitled "Community Concern for Youth" to be conducted by Todd-Wadena Community Corrections during the period from September 1, 2018, through December 31, 2018.

BE IT FURTHER RESOLVED that Rod Erickson, Chairperson, Todd County Board of Commissioners, is hereby authorized to execute such agreements and funding as are necessary to implement the project on behalf of the City of Menahga.

BE IT FURTHER RESOLVED that the City of Menahga hereby agrees to contribute \$1,475 for the project entitled Todd-Wadena Community Concern for Youth during the period from January 1, 2018 through December 31, 2018.
