WHEREAS, the current Comprehensive Plan for the City of Menahga was adopted by the City Council in 2012; and


WHEREAS, the City determined the 2012 Comprehensive Plan was outdated, and it would be in the interest of the City and its residents to repeal and replace; and



A Resolution Accepting Donation




